The 5,000 and 2,666 shares underlying the employee common stock option (right to buy) granted on December 31, 2009 (the "Replacement Grant") were granted in exchange for the tender by the Reporting Person of an option to purchase 15,000 and 8,000 shares granted to the Reporting Person on May 21, 2002 and May 20, 2003, respectively (the "Original Grant"). The Reporting Person tendered (1) the Original Grant pursuant to the terms of the Tender Offer Statement on Schedule TO filed by the Company with the Securities and Exchange Commission on December 2, 2009, as amended, relating to an offer by the Company to certain directors and employees to exchange certain outstanding options to purchase shares of common stock of the Company. Upon grant of the Replacement Grant to the Reporting Person, the Original Grant was canceled in its entirety.

(2) The Original Grant vested over a period of one year from the date of grant, with 50% vesting on each of the first two six-month anniversaries of the date of grant.

(3) The Replacement Grant will vest over a period of one year from the date of grant, with 50% vesting on each of the first two six-month anniversaries of the date of grant.
